Proposed Town Council for Wilmslow

One of the core reasons behind the creation of the new Cheshire East Unitary Council was the assumption of local representation through a Town or Parish Council, for example such as those already in place in Alderley Edge, Knutsford and Poynton.

Many Wilmslow residents believe that our town deserves such representation, to ensure that we have the same opportunities to express our views on local issues.

The attached FAQS sheet gives answers to any questions that you may have about the need for such a Council, how it would work and how much it would cost.

Having giving detailed consideration to this, the PPRA Committee has concluded that a Town Council **would** be beneficial for the residents of Pownall Park. We are therefore strongly in support of the proposal.

For the proposal to proceed, at least 10% of Wilmslow voters need to support it by way of signed petition. This means that 2,600 signatures are required. A large number of people have already signed the petition, but more signatures are required. We have therefore copied the standard form of petition to the reverse of the FAQS sheet. Any resident over the aged of 18 can sign the petition.

If you agree with the proposal, all supporting adults in your household should sign the petition (don't worry if you do not know your electoral number). Please return the completed form **BY FRIDAY 23 OCTOBER** to:

Field behind Gorsey School

Following the submission of nearly 100 forms of support and evidence, The Friends of Gorsey Field submitted an application for Village Green status at the end of March 2009. There was a subsequent delay to the consideration of the application, given the transfer of local authority from Cheshire County Council to Cheshire East.

The application is to be considered by a Cheshire East solicitor who is independent of the land owning Cheshire East Education Authority.

Formal notification of the application was publicised through the Wilmslow Express and other sources three months ago, with objections to the application to be submitted by 2 October.

We understand that Cheshire East Education Authority and Gorsey School have submitted their reasons for objection to the application.

Adjudication on the application is now awaited although there is no indication given as to how long this might take.

Parking

Over 130 residents responded to the parking survey which the Association distributed on behalf of Cheshire Highways. On those roads principally affected by daily parking, a large majority of residents were in favour of 'The Cheadle' solution to parking restrictions, the principles of which were discussed at our meeting at Gorsey School in May (principally comprising restrictions for part of the day only, so stopping parking for the whole of the working day). As with our earlier survey, the majority of Alton Road residents said that they did not want parking restrictions.

Cheshire Highways subsequently prepared Traffic Regulation Orders for the implementation of such parking restrictions on the roads most affected.

Objections have however been raised by some Pownall Park residents which are now being considered by the Highways team.

Maintenance of Pownall Park
